NOW IT IS HEREBY AGREED by and between the parties hereto as follows:

- (1) Giving first priority, the party of the second part shall approach the party of the first part whenever the party of the second part shall need co-operation and help of the party of the first part in respect of all or any of the areas mentioned hereinabove.
- (2) The party of the first part shall keep the party of the second part informed from time to time about the availability of trained personnel seeking jobs as skilled workers in the skills in which they may have completed training at VTC, Vaghaldhara.
- (3) The party of the first part shall keep the party of the second part informed about the type of help it may require from the party of the second part from time to time resulting into mutual benefit.
- (4) The party of the second part shall strive to help the party of the first part in helping the party of the first part to achieve its dream of acquiring the status of Centre of Excellence in its field.
- (5) This MOU is not binding to the party of the second part. However, it is made in order to ensure moral binding on the part of the party of the second part in respect of the promise hereinabove given.
